

Shariah Global Portfolio Promotion Campaign

Terms and Conditions

The following terms and conditions apply to the new and existing client promotions offered by StashAway during the Campaign Period (2 September – 31 October 2025). By participating, you agree to be bound by these terms.

1. Eligibility

1.1 The promotion is open to both new and existing clients who make a qualifying net deposit into the Shariah Global Portfolio during the Campaign Period.

1.2 A new client in the context of this campaign is defined as a client who has never deposited into any StashAway portfolio before the campaign launch date (2 September 2025).

1.3 Existing clients in the context of this campaign are defined as clients who have previously deposited with StashAway before 2 September 2025.

2. Promotion details

2.1 New clients reward: “Free investing for up to 12 months”

- Clients do not need to apply any voucher code to receive the reward.
- Rewards are based on the net deposit amount invested into the Shariah Global Portfolio during the Campaign Period.
- Clients must maintain their qualifying net deposit in the Shariah Global Portfolio until 31 October 2025 to remain eligible for the reward.
- The free investing reward waives StashAway’s management fees for the eligible amount and the duration stated in the tier table below:

Tier	Net deposit amount	Free investing duration
1	RM1,000–RM4,999	6 months
2	RM5,000–RM19,999	9 months
3	RM20,000 and above	12 months

2.2 Existing clients reward: “Free investing for up to 12 months”

- Existing clients must manually apply a promo code in the StashAway app to activate the reward. The reward waives StashAway’s management fees for the eligible amount and duration as outlined in the table below:

Tier	Net deposit amount	Free investing duration	Promo codes
1	RM1,000–RM4,999	6 months	SGPF6
2	RM5,000–RM19,999	9 months	SGPF9
3	RM20,000 and above	12 months	SGPF12

- To apply the promo code manually, follow the steps below:
 - Mobile: More (Top left corner in the app) > Promotions > Enter promotion code
 - Desktop: Settings > Enter promotion code
- Different promo codes activate different tiers of the reward.
- Rewards are based on the net deposit amount invested in the Shariah Global Portfolio during the Campaign Period.
- Clients must maintain their qualifying net deposit in the Shariah Global Portfolio until 31 October 2025 to remain eligible for the reward.
- Only one promo code can be activated per client, and only one reward tier will apply — based on the highest qualifying net deposit made during the Campaign Period.

3. Qualifying portfolios and criteria

3.1 Eligible portfolios

Only deposits made into the Shariah Global Portfolio are eligible for the campaign rewards. Deposits made into the following portfolios do not qualify for this promotion:

- StashAway Simple™
- General Investing by StashAway
- General Investing by BlackRock®
- Responsible Investing
- Flexible Portfolios
- Thematic Portfolios

3.2 Fresh funds requirement

- Only new deposits made during the Campaign Period qualify.
- Either a single fresh deposit or cumulative fresh deposits into the Shariah Global Portfolio during the Campaign Period will count toward the net deposit calculation.
- Internal transfers between StashAway portfolios are not eligible.

- Any withdrawals made during the Campaign Period will affect the final net deposit amount used to determine eligibility and reward tier.

4. General

4.1 StashAway reserves the right to modify, suspend, or terminate the campaign or its terms and conditions at any time, without prior notice.

4.2 In the event of suspected fraud, manipulation, or abuse, StashAway may disqualify participants or revoke rewards at its discretion.
