

StashAway x SingSaver Exclusive Promotion

Terms & Conditions

(1) Overview

Customers who successfully open a StashAway Account with StashAway Pte. Ltd. (“StashAway”) via SingSaver during the Promotion Period, fund the account with the required minimum deposit, and maintain it for 30 days, while completing all other requirements stated below, will be eligible to receive the specified Promotion Reward.

(2) Promotion Period

This Promotion is valid from 18 November 2025 onwards until further notice (“Promotion Period”). Deposits made prior to 18 November 2025 will not qualify under these Terms and Conditions.

(3) Eligibility

To qualify as an Eligible Customer, you must meet all of the following conditions during the Promotion Period:

a. Residency

You must be a Resident of Singapore. This includes Singapore Citizens, Singapore Permanent Residents, and foreigners holding Employment Passes, S Passes, or Work Permits.

b. New StashAway Customer

You will be considered a New StashAway Customer if you sign up for a StashAway account and make your first qualifying deposit during the Promotion Period.

c. Application via SingSaver

You must apply for a StashAway Account through SingSaver by:

- Clicking “Apply Now” for StashAway on the SingSaver Website
- Being redirected to the SingSaver-exclusive StashAway offer page (<https://www.stashaway.sg/ref/singsaver-exclusive>)
- Clicking “Start investing today” and completing registration in the StashAway app

d. Rewards Redemption Form

Eligible Customers must complete and submit the SingSaver Rewards Redemption Form sent to their registered email address, including their StashAway account reference number, within 14 days of completing their application.

e. Account Approval

Your application for a StashAway Account must be approved by StashAway.

f. Funding Requirement

You must fund and maintain at least one of the following tiers for 30 days from the deposit date:

- Tier 1: \$7,000 SGD in Cash Management portfolios; or
- Tier 2: \$500 SGD in Investment portfolios or ETF Explorer

Note:

- Cash and SRS deposits are eligible.
- Only the first instance in which a participant's net deposits meet or exceed the qualifying threshold will start the 30-day maintenance period. If the net deposit amount subsequently falls below the threshold due to withdrawals and later exceeds the threshold again through additional deposits, the 30-day maintenance period will not reset or restart.
- Any outward internal transfer between different product tiers (e.g. from Cash Management to Investment Portfolio / ETF Portfolio) will be treated as a withdrawal from the originating product, but will not be counted as a new deposit into the receiving product for the purposes of net deposit calculations.
- Internal transfers within the same tier (e.g. transfers between portfolios within the same tier) will not affect the net deposit calculation.

(4) Reward Fulfilment

- Clients do not need to apply any voucher code to receive the reward. The voucher will be automatically applied when signing up through the StashAway x SingSaver landing page.
- Eligible Customers will receive \$30 SGD cash via PayNow once they meet all the above eligibility conditions.
- Each Eligible Customer is entitled to one Promotion Reward only, regardless of the number of qualifying deposits or accounts.
- All eligible transactions will be consolidated and verified in the month following the holding period.
- Rewards will be fulfilled within three (3) months after the 30-day holding period and verification are completed.
 - For example, transactions completed in January will be verified in February, and rewards will be fulfilled within three (3) months after verification.

- Private Infrastructure (Semi-liquid)

b. Cash Management Portfolios

The following cash management portfolios qualify for the campaign rewards:

- Simple
- Simple Plus

Simple Fixed do not qualify for rewards.

c. ETF Explorer

Any ETF invested via ETF Explorer is eligible for the campaign reward
